

REGULATIONS

of the EUROPEAN YOUTH ONCOOLYMPICS

§ 1. GENERAL PROVISIONS

1. These Regulations, hereinafter referred to as the “Regulations,” govern the organization of the sports and cultural event titled the “European Youth Oncoolympics,” hereinafter referred to as the “Oncoolympics.”
2. The organizers of the Oncoolympics are:
 - a. University of Health and Sports Sciences in Wrocław, located at al. Ignacego Jana Paderewskiego 35, 51-612 Wrocław, NIP: 8960007519, REGON: 000327860, hereinafter referred to as “AWF”;
 - b. Saving Kids with Cancer Foundation, based in Wrocław, at ul. Ślężna 114s/1, 53-111 Wrocław, registered in the Register of Associations maintained by the District Court for Wrocław-Fabryczna, 6th Economic Division of the National Court Register, under KRS number: 0000086210, NIP: 8971401390, REGON: 931533690, hereinafter referred to as the “Foundation”;collectively referred to as the “Organizers,” and each individually as an “Organizer,” with the participation of, among others, the strategic partner, the Polish Society of Pediatric Oncology and Hematology (“Partners”).
3. These Regulations apply to all individuals present on the premises where the Oncoolympics are held (“Participants”). All individuals on these premises, regardless of their status as Competitors or other, are required to comply with these Regulations.
4. The purpose of these Regulations is to establish the terms of participation in the Oncoolympics and ensure safety by specifying conduct rules on the event premises.

§ 2. PURPOSE OF THE ONCOOLYMPICS

1. The goals of the Oncoolympics include:
 - a. strengthening bonds and mutual support among children and youth undergoing or recovering from oncological treatment, along with their caregivers and families;
 - b. promoting health and physical fitness among children and youth;
 - c. encouraging physical activity and its positive impact on health and well-being;
 - d. facilitating interaction between Europe’s medical community and European patient organizations;
 - e. fostering understanding and social acceptance for children and adolescents affected by cancer.

§ 3. DATE AND LOCATION OF THE ONCOOLYMPICS

1. The Oncoolympics will take place from June 6-8, 2025, in Wrocław (the “Oncoolympics Date” or “Date”).
2. The general schedule of the Oncoolympics is as follows:
 - a. June 6, 2025: Participant check-in,
 - b. June 7, 2025: Competitions at the AWF athletics stadium located at ul. Witelona 25a, Wrocław (“Location” or “Premises”),
 - c. June 8, 2025: Participant check-out.
3. Accompanying events may also take place at other AWF facilities within Wrocław. The detailed schedule and venues for each event will be provided by the Organizers in the Oncoolympics Program (“Program”), made available on the website at least 7 days before the event.
4. In the event of any changes to the Location or Date, the Organizers will notify registered organizations at least 3 days in advance using the contact details provided in the Organization Registration Form.

§ 4. COMPETITOR APPLICATION AND REGISTRATION

1. A Competitor in the Oncoolympics may be an individual aged 7-21 who is a pediatric oncology patient undergoing maintenance therapy or is in recovery (“Competitor”), registered for participation by an authorized organization as stipulated in these Regulations. A minor under 18 must participate under the supervision of an adult.
2. To participate in the sports competitions, Competitors must provide a certificate from their attending physician, in English or Polish, confirming they are fit for sports activities. This certificate must be issued no more than 7 days before the competition begins.
3. Final qualification and approval for participation will be determined by the doctor representing the Competitor’s team. The Organizers reserve the right to disallow a Competitor if on-site medical personnel deem participation a risk to health or safety.
4. The number of Competitors is limited to 160 (“Participant Limit”).
5. Competitors may only be registered through foundations, organizations, associations, or other entities supporting pediatric oncology patients and their families (“Organizations”). Each Organization, regardless of origin, may register a maximum of 10 Competitors (“Organization Limit”), collectively forming a “Team.”
6. There is no possibility to increase the Organization Limit. However, substitutions are permitted if a registered Competitor becomes unable to participate, provided the substitute meets all eligibility criteria in § 4.1. Substitutions must be reported to the Organizers at least 14 working days before the Oncoolympics begin.

7. Organizations may only gain registration rights by completing the online registration form between November 13, 2024, and February 14, 2025.
8. There is no limit on the number of Organizations that may register Competitors, subject to the Participant Limit. Any subsequent registration submitted by an already registered Organization or a newly registered Organization that exceeds the Participant Limit will be placed on the Reserve List.
9. To obtain the right to register Competitors for participation in the competitions, an Organization must complete the registration form available on the website: www.oncoolympics.com and www.onkoigrzyska.pl (the "Organization Registration Form") between November 13, 2024, and February 14, 2025.
 - a. In the Organization Registration Form, the Organization must designate a contact person who will communicate with the Organizers to complete the registration of Competitors.
 - b. From November 13, 2024, to January 15, 2025 (inclusive), an "Early Bird Special" will apply. Organizations that submit a complete list of Competitors, including all required personal and medical data forms ("Competitor Form"), by January 15, 2025, at 23:59:59, are eligible for the Organizers to cover travel and accommodation costs for the duration of the Oncoolympics.
 - c. Coverage of additional expenses beyond the specified time frame or scope will be reviewed by the Organizers upon request by the Organization.
 - d. All other benefits regarding the Early Bird Special will be subject to individual arrangements with each Organization.
10. Competitor Forms will be sent by email to the contact persons designated by the Organizations in the Organization Registration Form. The Competitor Form will be available in Polish and English.
11. Completion of the Competitor Form by the Organization must include at least the following information: (i) full name, (ii) date of birth, (iii) email address and contact phone number (for minors, the contact details of a legal guardian), (iv) residential address, (v) height and weight of the Competitor, (vi) Competitor's shirt size, (vii) Competitor's diagnosis, (viii) place of treatment, (ix) treatment start date, (x) personal data in compliance with data protection and sensitive data laws in the Competitor's country.
12. The Organizers reserve the right to increase or decrease the number of mandatory questions in the Competitor Form.
13. Organizations must submit completed Competitor Forms to the Organizers by May 7, 2025 ("Deadline") to the following email address: info@oncoolympics.com
14. Competitor Forms submitted after the Deadline do not guarantee participation in the competitions.
15. Submission of a fully completed Competitor Form by the Organization by the Deadline is required for a Competitor's participation in the competitions. The

Organizers are not liable for non-admittance due to an incomplete or improperly completed Competitor Form.

16. Registrations submitted after the Deadline or registrations exceeding the Limit, i.e., the Participant Limit or Organization Limit, will be placed on the reserve list ("Reserve List"). The order of the Reserve List will be based on the submission date of the completed Organization Registration Form. Representatives of the Organizers will contact Organizations on the Reserve List as spots become available.
17. After submitting the Organization Registration Form, the Organization will receive a registration confirmation for the Oncoolympics via email to the address provided in the Form.
18. For any matters, particularly those requiring changes to registered information in the Organization Registration Form or withdrawal from the Oncoolympics, the Competitor should contact the Organizers through the Organization that registered their participation or, in urgent cases, directly via the following email address: info@oncoolympics.com.
19. The Organizers reserve the right to close registration for the Oncoolympics before the Deadline if the Limits are reached, with further registrations being placed on the Reserve List.
20. The data protection policy for Competitors' personal data in the Organization Registration Form is available via an active link within the Form.

§ 5. ONCOOLYMPICS PROGRAM

1. The full Oncoolympics Program, detailing all sports and accompanying events, including dates and locations, will be published on the official websites – www.oncoolympics.com and www.onkoigrzyska.pl no later than June 1st, 2025. The Organizers may release a preliminary Program at an earlier date.
2. During the Oncoolympics, Competitors participate in sports competitions organized by age and gender categories as outlined in § 6 pt. 3.
3. Registered Competitors are required to arrive on time to collect their Starter Packs.
4. Participants are responsible for arranging their transportation to the Oncoolympics at their own expense, with the exceptions made in § 4 pt. 9 subpt b of the Regulations.
5. Entry to the Oncoolympics is free of charge for all Competitors and Participants.

§ 6. SPORTS COMPETITIONS

1. Sports activities at the Oncoolympics include warm-ups, track and field competitions, and soccer games.

2. As a form of a warm-up, chosen activities from the EUROFIT standardised physical fitness test will be conducted.
3. Track and field events will include:
 - a. 60m sprint (from a crouched start),
 - b. Ball throw,
 - c. Long jump.
4. The track and field events will be held in the following age categories, separately for boys and girls:
 - a. 7-9 years,
 - b. 10-12 years,
 - c. 13-14 years,
 - d. 15-18 years,
 - e. 19-21 years.
5. The soccer games will follow these technical guidelines:
 - a. Game duration:
 - a. 2 halves of 5 minutes each for group and final matches,
 - b. Field dimensions: a designated area measuring 25-30 meters in width and 45-50 meters in length,
 - c. Goals: one goal at each shorter end of the field, measuring 5 meters in width and 2 meters in height,
 - d. Penalty kick: positioned 9 meters from the goal,
 - e. Penalty area: a designated area measuring 15 meters by 9 meters,
 - f. Team: a group of Competitors from a single team, with a maximum of 7 players from that team on the field at any one time.
6. The system for the soccer games will operate according to the following rules:
 - a. National Representative teams are randomly divided into two groups, where matches are played in a “round-robin” format,
 - b. The top two teams from each group—those finishing in first and second place—advance to the semifinals. Semifinal matches will follow an A1-B2, B1-A2 format, where the first-place team from one group plays against the second-place team from the opposite group,
 - c. The winning teams of the two semifinals will play a final match according to the same rules.
7. During the game, teams may make an unlimited number of substitutions during breaks in play, and substitutions can also be reversed.
8. A team earns 3 points for a win, 0 points for a loss, and 1 point each in the case of a draw.
9. The ranking of teams, particularly for those securing first and second places to advance to the semifinals, will be determined in the following order of priority:
 - a. Number of points earned in group matches,

- b. If two or more teams have the same number of points, an additional match will be played between the tied teams according to the standard rules in section 5,
 - c. If the tiebreaker match ends in a draw, a penalty shootout will be conducted as per the guidelines established by the Organizers,
 - d. If ranking cannot be determined by these means, the Organizers will conduct a final, binding draw.
10. The Organizers reserve the right to clarify, adjust, and make ongoing modifications to the process described in sections 6-9 above at any time, with the requirement of informing Competitors before the next stage of the process begins.

§ 7. AWARDS

1. Each Oncoolympics Competitor will receive a participation certificate and a prize.
2. Medals are awarded for places I-III in each age category and event.

§ 8. ORGANIZATIONAL AND SAFETY RULES

1. The Oncoolympics are open to the public, and entry to the Oncoolympics Premises is free of charge.
2. It is prohibited to bring or possess the following items on the Oncoolympics Premises:
 - a. weapons or other dangerous items,
 - b. explosives,
 - c. pyrotechnic products,
 - d. flammable materials,
 - e. alcoholic beverages,
 - f. drugs, psychotropic substances, or any similar substances.
3. Any commercial or other profit-driven activities are strictly prohibited on the Oncoolympics Premises.
4. The Organizers of the Oncoolympics reserve the right to deny entry to or remove individuals from the Premises who:
 - a. are visibly under the influence of alcohol, drugs, psychotropic substances, or similar agents,
 - b. possess weapons, dangerous items, explosives, pyrotechnics, flammable materials, alcoholic beverages, drugs, or psychotropic substances,
 - c. behave aggressively, provocatively, or in any way that threatens the safety or order of the event,
 - d. refuse to submit to security checks (such as checking for permits, ID, or inspection of baggage or clothing).

5. Participants in the Oncoolympics and all others on the Oncoolympics Premises are required to follow the instructions of the Organizers and security personnel responsible for maintaining safety and order during the event.
6. Minors are only permitted on the Oncoolympics Premises under the supervision of an adult, who assumes full responsibility for their safety.
7. The Organizers ensure the safety of all individuals present at the Oncoolympics and maintain order through measures such as:
 - a. providing information services,
 - b. offering medical assistance,
 - c. making sanitary facilities available.
8. The Organizers are not liable for situations arising from non-compliance with the above provisions or with instructions from security personnel.
9. The Organizers are not responsible for any property left unattended on the Oncoolympics Premises.

§ 9. RECORDING OF THE ONCOOLYMPICS

1. The Organizers may record the Oncoolympics for documentation, reporting, advertising, and promotional purposes, which may include Participants' and Competitors' likenesses and voices. No claims are granted to Participants or Competitors for these recordings.

§ 10. FINAL PROVISIONS

1. The Organizers are not liable for the consequences of force majeure. Force majeure is defined as an event beyond the Organizers' control that renders the fulfillment of obligations impossible or may be considered impossible due to the circumstances. Force majeure includes, but is not limited to, weather conditions, failures or disruptions of devices supplying electricity, heat, or light, acts of war, or actions by state or local authorities in setting policies, laws, and regulations that impact the fulfillment of obligations.
2. These Regulations come into effect on November 5, 2024, and remain in force until the conclusion of the Oncoolympics.
3. Participation in the Oncoolympics implies acceptance of these Regulations.

5. These Regulations may be amended by the Organizers. In such cases, the Organizers are obligated to inform Participants of any changes via the email addresses provided in the Organization Registration Form.
